INSTRUCTIONS TO AUTHORS

THE JOURNAL OF COASTAL RESEARCH is published quarterly in English by the Coastal Education and Research Foundation, Inc. [CERF]. The journal includes the following main sections: Professional Reports, Technical Communications, Reports of Meetings, Letters to the Editor, News and Announcements, Book Reviews, Books Received, New Citations in Coastal Topics, Coastal Calendar, and Abstracts of Recent Literature.

PROFESSIONAL REPORTS: Original contributions dealing with coastal environmental problems are of prime interest and will be given priority in publication. Manuscripts dealing with theory, methodology, techniques, applied topics, and case studies are also appropriate for publication in the journal.

Periodic reviews of history, state-of-the-art summaries, and progress on specific topics or problems are welcome. Topical reviews in specialized subjects should feature classical interpretations of contentious issues as well as modern developments.

NEWS AND ANNOUNCEMENTS: Announcements, discussions, and reports of supporting organizations and other associations with coastal themes and interest highlight this section. Brief descriptions of representative professional activities and news items of international, national, or regional interest are also relevant here.

LETTERS TO THE EDITOR: Critical observations (pro and contra) and clarifying discussions of articles appearing in the journal will be published as soon as possible along with the author's reply. Brief and pertinent responses are encouraged.

COASTAL PHOTOGRAPHS: Black and white photographs of general interest will be published as "Coastal Photograph by..." as a single entry with an appropriate caption (it is helpful to include latitude and longitude, date, weather conditions, and description). Refer to previous issues for photo proportions and submit proofs to the Editor-in-Chief.

COLOR PLATES: Special color plates will be considered for inclusion on a basis of necessity. Color slides (35 mm) may be submitted, on an exceptional basis, with articles but must be numbered separately (as plates). Single pictures of outstanding interest will be considered also, in the "Coastal Photography" category.

CAPTIONS: Photographs and line drawings require clear and concise captions. The captions should be typed and numbered consecutively, each to a separate sheet of paper. These sheets should be grouped together at the end of the manuscript. Maps, photomicrographs, or other illustrations that are affected by enlargement or reduction must incorporate a bar scale.

MANUSCRIPT REQUIREMENTS: Research manuscripts must be original and not currently being considered for publication elsewhere. Research manuscripts, reviews, and technical communications, in general should be organized in the following order: (a) title; (b) names and affiliations of authors; (c) abstract; (d) index words; (e) introduction; (f) methods, materials, study area; (g) results; (h) discussion; (i) conclusions; (j) acknowledgements; (k) literature cited; (l) tables (each to a separate page); (m) figure captions (each to a separate page);

For general guides to manuscript lay-out and style, contributors are referred to: *A Manual of Style* (1982), The University of Chicago Press; *Suggestions to Authors of the Reports of the United States Geological Survey* (1958), U.S. Government Printing Office, Washington, D.C.; *Geo-writing — A Guide to Writing, Editing, and Printing in Earth Science* (1973), American Geological Institute, Washington, D.C.

Manuscripts must be typewritten on one side of white bond paper and double spaced, including abstracts and references, on unbound pages of uniform size not more than 30 cm in length. Number all pages through the reference section beginning with the abstract. The abstract should be direct and concise with no more than 250 words. In the text, first order headings are capitals centered; second order headings are upper and lower case flush left; third order heads are upper and lower case indented; fourth order heads are upper and lower case, indented as a paragraph and running into copy.

TABLES: Although all tables will be included in the main body of the manuscript when printed, they should be submitted separately each to a page after the references. They should be numbered consecutively, appropriately headed, and kept as simple and short as possible. If additional information is required, such as units of measure or brief comments, it should be appropriately footnoted at the bottom of the table. Avoid vertical lines and complicated mathematical expressions in the body of the table. Longer appendices must have a title and should be placed at the end of the text after "Literature Cited."

ILLUSTRATIONS: Black and white photographs and line drawings are to be numbered in a single sequence as "Figure 1," "Figure 2" etc., and so referred to in the text. Each must be clearly captioned and acknowledged when necessary. All drawings should be identified by the author's name in the margins and on the backs of photographs. Make note in the margin the first time an illustration is referred to or alongside the passage of text near which the illustration should appear ("Figure 3 near here"). The International System of Units (SI) or modern metric units should be used. Equivalents, if necessary,

may be included in parentheses immediately following the acceptable units.

All line drawings containing patterns, lettering, or numbers must be suitable for reduction to the following sizes: 7 cm column width, 14.5 cm page (2 columns) width, 12.5 x 22 cm turn page. No lettering can be reduced smaller than 1 mm in height. Do not provide oversize originals. Stats or clear photographic copies are required for acceptable reproduction. Do not supply xerographic copies for the master illustration.

MATHEMATICAL SYMBOLS: Marginal notes must be added to the master copy to explain symbols used in the text; for example, "lower-case lambda" λ , "upper-case phi" Φ , "lower-case gamma" γ and other special symbols. Explanations need to be given only the first time a symbol or special expression is used.

FOOTNOTES: Footnoted information should be written in the text whenever feasible. If inclusion of explanatory information is unavoidable, the footnoted material should be provided on a separate typed sheet of paper that is numbered consecutively in the manuscript pagination.

SCIENTIFIC NAMES: Plant and animal genera, subgenera, species, and lower taxa need to be underlined for italic, specific and lower epithets being written with a lower case initial letter. Nomenclature should follow the appropriate international code. Geological ecological, and other scientific terms should follow standard usage or be defined the first time they are employed in the paper.

TITLES AND RUNNING HEADS: All titles should be as short as possible, *inter alia* for use as running heads. If the title is longer than 50 characters, including blank spaces and punctuation, please provide a shorter form on the first page of the manuscript. Those for professional reports will be balanced by short titles and author's names on the tops of pages.

LITERATURE REFERENCES: Literature citations are generally treated according to the "Harvard System." In the body of the text they are cited by naming the author (or authors connected by "and" if two, or with *et al.*, replacing all names after the first if more than two) and indicating the year of publication in parentheses: e.g., "(Jones, 1980)." Papers cited should be grouped together in a list headed "Literature Cited," alphabetically arranged by first authors' surnames but unnumbered, at the end of the body of the paper. There all authors' names and initials are required, followed by the date of publication and the full title of the paper. Then follows the full title of the periodical, undelined for italic, then the volume and issue numbers in Arabic numerals, and finally the page spread. For books, the title is given underlined for italic, and then the place of publication followed by the bare name of the publisher and total number of pages. The list of references to journal articles and books should follow the format shown below:

Other examples are to be found in any issue of the journal.

Unpublished data, reports, research, or proprietary information should be cited in the text following the author's name — for example (A.B. Smith, unpublished data) — but should not appear again in the reference section. An exception is unpublished theses and dissertations; they are treated as publications in the text — for example (Jones, 1985) — but cited as books in the references.

PROOFS: Manuscripts that require extensive copyediting will be sent to the first named or senior author. Senior authors may designate a "corresponding" author to make final changes or check proofs but this should be made known to the Editorial Office immediately. All changes in wording, minor changes in factual material, and updating of references **must** be done on edited copies of the manuscript. When an edited paper is returned to the Editorial Office, it is presumed to be in its final form.

Printer's proofs will be sent to the author (or first named if more than one) of each professional paper (but not editorials, conference reports, news, or letters). Only necessary corrections can be made in proof due to increasing costs of altering set pages. The publisher reserves the right to "pass for press" if author corrections are not received in time. Authors receiving proofs should check with their co-authors concerning corrections and ordering of reprints.

REPRINTS: Copies of professional reports and technical communications may be ordered at the page proof stage or at a later date providing it does not exceed the time of publication by twelve months. Offprints will be sent to the author (or first named if more than one) of each signed paper. Printed covers, if desired, may be ordered at the prices indicated on the form accompanying the proofs.
